

## **ACTION NEEDED!**

None of these new forced flu shots directives are the result of new laws, all are dictates by either an appointed bureaucrat, or in the case of Massachusetts, an appointed bureaucrat running interference for Governor Charlie Baker, the former head of a Harvard Pilgrim, a massive HMO. Perhaps this indicates that the vaccine rights movement has grown to the extent that legislators no longer want to deal with these political hot potatoes and are leaving it up to the commissars. But if these directives are allowed to stand, it also shows that the range of people with the authority to make fundamental healthcare decisions for us and our children is expanding, while the ability we have to decide what is done to our bodies and our children's bodies is diminished.

Janet Napolitano, a lawyer and President of the public University of California, as a parting gift before she left office on August 1, issued an order dated July 31, requiring all students, faculty and staff to get flu shots by November 1. Religious and medical exemptions will be allowed. Children's Health Defense has announced they will be filing a lawsuit against the University of California to stop enforcement of the order.

Columbia University, a private University in New York City, issued a directive last week that all undergraduates, and graduate students who either live, or come onto the campus, must be vaccinated as well. Staff and faculty are not required to get the injections. Religious and medical exemptions for colleges are required by New York State law. Nothing under New York or federal law gives a post-secondary educational enterprise like Columbia the authority to require medical procedures of its customers.

And the corporate media is joining the course with recent articles pushing mandatory flu shots from Vox, CNN, Yahoo and others, calling for flu shots for everybody. It seems likely other states and institutions may follow suit.

The decision-makers are trotting out "flattening the curve" again as the ostensible reason for the orders, claiming that flu season can bring on a second wave of covid 19 and that the healthcare system will be overwhelmed. "It is more important now than ever to get a flu vaccine because flu symptoms are very similar to those of COVID-19 and preventing the flu will save lives and preserve healthcare resources." said Dr. Larry Madoff, Medical Director of the Massachusetts Department of Public Health Bureau of Infectious Disease and Laboratory Sciences in a statement.

Flu shots do nothing to prevent covid 19. There is no evidence to support that contention, and in fact a US Department of Defense study showed that people who get flu shots are 36% more likely to get an infection from the covid group of viruses.

Flu shots are unpredictable and frequently completely ineffective. According to multi-decade studies of flu shot efficacy by the Cochrane Collaboration, flu shots in children age 3-16 reduce the risk of influenza in children from 30% to 11% on average. In some years, like 2017, flu shots have no measurable efficacy at all, even in the best-case scenarios devised by the flu shot manufacturers. In some years, children receiving flu shots are more likely to get the flu. There is insufficient data according to the Cochrane Collaboration to even say what affect flu shots have on children under 2.

The vast majority of Americans choose not to get flu shots for themselves or their children despite the fact that they are readily available, usually at no cost.

These are the first orders we are aware of that will require adults, not in healthcare employment, to get flu shots.

No states, except now Massachusetts, require flu shots to attend K-12 schools.

No states except, except now Massachusetts, require flu shots to attend college.

According to package inserts for flu shots side effects include fever, headache, fatigue, body pain and upper respiratory tract congestion, i.e. a case of the flu.

Flu shots are not routinely recommended for children in the vast majority of developed democracies including Germany, Japan, France, Italy, Spain and the

Scandinavian countries. All countries that have substantially better health outcomes for their children than the US.

Inhaled flu vaccines contain live strains of the flu virus and render people who receive it infectious for several weeks after administration. How inhaled flu vaccines reduce the prevalence of flu is not clear.

Only two states, New Jersey and Connecticut, and New York City, require flu shots for pre-schoolers. None of these jurisdictions have even presented any evidence that forced flu shots result in better health outcomes for children.

Some flu shots in the US (approximately 20%) are still made using thimerosal, an obsolete preservative based on toxic mercury, that is banned in most of the world, but not the US.



## The CDC Presents "A Comedy of Errors" A Tragedy in Three Parts

### Part One: CDC Public Health Response

The responsibility for the public health response to any pandemic threat lies squarely on the shoulders of the Centers for Disease Control and Prevention/CDC. Swift, accurate, and reliable diagnostic testing for SARS-Cov2 would have made a huge difference (along with contact tracing in the initial stages) in containment. What did our CDC do? ### **Part Two: CDC Flawed PCR Testing**

“We’ve been hijacked by our technologies, but left illiterate about what they actually mean.” (1)

#### **What is a PCR test?**

Developed in the early 1990’s by Kary Mullis, he was awarded the Nobel Prize for his Polymerase Chain Reaction test. The intended use of the PCR was (and still is) as a manufacturing technique, with the ability to replicate DNA sequences millions and billions of times, and not as a diagnostic tool to detect viruses. Because Sars-CoV2 is an RNA virus, the actual test used is officially called the RT-PCR (reverse transcription polymerase chain reaction). Reverse transcription with an enzyme turns viral RNA into DNA. Other enzymes can then amplify the DNA in order to identify it.

In 2007, epidemiologists and infectious disease specialists recognized that they placed too much faith in a quick and highly sensitive molecular test that led them astray. “There are no national data on pseudo-epidemics caused by an overreliance on such molecular tests, said Dr. Trish M. Perl, an epidemiologist at Johns Hopkins and past president of the Society of Health Care Epidemiologists of America.”




