Dear Governor Lamont,

The Democratic Leadership in the Senate and House are advancing a bill which will repeal the religious exemption to vaccination for school children. It is being accomplished via party line votes. (1)

SB568/HB6423 exemplifies unnecessary government overreach. The bill seeks to address a problem that does not exist, violating critically important religious liberty, human rights, and bioethics principles. The bill will cause families to uproot and leave CT based on their religious beliefs or face religious discrimination if they stay in CT. If these party line votes bring this bill to your desk, here are five reasons to veto it.

REASON #1: ACCORDING TO CT'S OWN SURVEY DATA, THERE IS NO PROBLEM TO SOLVE IN CT SCHOOLS. THIS BILL IS UNNECESSARY GOVERNMENT OVERREACH.

Religious exemptions and school vaccination mandates can continue to co-exist as they have done for the past 60 years! The DPH survey numbers from February 2021 show that CT is currently at a 97.5% vaccination rate and that BOTH religious and medical exemptions actually FELL in the 2019-20 school year. Veto it because it's completely unnecessary. (2)

REASON #2: UNLIKE NY OR CA, CT IS A RELIGIOUS LIBERTY LEADER.

CT was founded by Puritans. New England (and the US) invented religious freedom. CT has a much stronger connection to preserving the principle of religious liberty than either NY or CA. Discriminating against the religious is wrong. Watch Dr. Paul Offit admit there are aborted human fetal DNA fragments in some vaccines on the CT childhood schedule. Watch Dr. Stanley Plotkin describe the use of fetuses. Veto it to preserve religious liberty. (3, 4, 5, 6, 7)

REASON #3: VACCINE MANDATES VIOLATE HUMAN RIGHTS AND LEAD TO DISCRIMINATION OF THE RELIGIOUS.

The Universal Declaration on Bioethics and Human Rights clearly states that it is a human rights violation to withhold access to school for not consenting to a vaccine. Article 6 reads, “Any preventive ... medical intervention is only to be carried out with the prior, free and informed consent of the person concerned, based on adequate information. The consent should, where appropriate, be express and may be withdrawn by the person concerned at any time and for any reason without disadvantage or prejudice.” Veto it to protect human rights because denying children access to public school is a disadvantage and prejudice. (8)

REASON #4: VACCINE MANDATES VIOLATE INTERNATIONAL BIOETHICS STANDARDS WHICH PRIORITIZE THE INDIVIDUAL OVER THE STATE.

The true bioethics standard for vaccines prioritize the INDIVIDUAL over society. Propaganda from the Pharmaceutical lobby obscures the true bioethical standards to increase revenue. Article 3 reads, “The interests and welfare of the individual should have priority over the sole interest of science or society.” Veto it because it’s the ethical thing to do (now that you know the true ethical standard). (9)

REASON #5: DON'T CREATE ANOTHER REASON FOR FAMILIES TO LEAVE CT.

Thousands of religious freedom refugee families left NY after 2019, making Governor Cuomo “Realtor of the Year” in FL, NC, SC, and TN among others. Thousands of families left CA after 2015, making current Governor Newsom “Realtor of the Year” in TX, AZ, CO, and ID among others. If you sign this bill, you will become New Hampshire’s “Realtor of the Year.” CT is already losing population. You are on record as wanting to increase CT’s population. Veto the bill to avoid creating religious freedom refugees. (10, 11)

Public health is an important interest for the state, but so are the fundamental right to public education and maintaining the American

principle of religious liberty. The DPH survey data clearly shows that CT can continue to offer religious exemptions without harming public health.

For these reasons, please veto SB568/HB6423. (12)

Children's Health Defense's New Film 'Medical Racism' Exposes Long-Standing Experimentation on Minorities

The film, which premiered March 11, chronicles the medical cartel's history of targeting minorities for unethical experiments, the acquiescence of regulatory agencies and medical ethicists, and the silence of of physicians who allow these atrocities to continue today.

"Medical Racism," illuminates the shocking history of government health regulators and private pharmaceutical companies conducting human experiments on Black Americans.

"Though many Americans are familiar with the history of medical atrocities committed by the Centers for Disease Control and Prevention at Tuskegee, by the father of American gynecology, Dr. J. Marion Sims, on South Carolina slave girls and the continuing medical larceny against Henrietta Lacks, most people are likely unaware of the routine medical barbarism committed against Africans that persists today," said Curtis Cost, the film's co-producer.

The documentary, directed by Academy Award nominee David Massey, chronicles the medical cartel's long history of targeting minority populations for unethical experiments, the acquiescence of regulatory agencies and medical ethicists, and the silence of physicians who allow these atrocities to continue today.

According to "Medical Racism" producer Kevin Jenkins of the Urban Global Health Alliance: "These racially targeted experiments have been hiding in plain sight for decades. It's time to expose the truth and end inhumane and barbaric forms of racism by the 'respected' medical establishment."

"Medical Racism" explores the recent racially based experimentation by government health officials and pharmaceutical companies on Black children in South Central Los Angeles.

The film also exposes Big Pharma's medical experiments and "drug dumping" in modern-day Africa, and the World Health Organization's 2014 population control

campaign to sterilize a million Kenyan girls with infertility chemicals hidden in tetanus vaccines.

"The high levels of medical mistrust in the Black community are a rational response to routine callousness and systemic savagery toward Blacks by medical professionals and pharmaceutical interests," said Robert F. Kennedy, Jr., chairman of Children's Health Defense. "Our hope in producing this film is to learn from past misdeeds, so we can avoid their future repetition."

Stanley Plotkin, "the Godfather of Vaccines", Reacts to Being Questioned About Vaccine Safety By Calling on The Gates Foundation, Vaccine Manufacturers, and Others to Better Organize, and Prepare Defenses of Vaccination

During that deposition, Dr. Plotkin made a number of admissions regarding vaccine clinical trials and gaps in safety data related to vaccines. Following that deposition, Dr. Plotkin put a number of wheels in motion, however none of those actions actually addresses the true concerns of many parents and patients.

Four months after his deposition, Dr. Plotkin sent a written statement to the American Academy of Pediatrics' Committee on Infectious Disease Vaccine Subcommittee as well as Amanda Cohn, the CDC liaison to the committee. In this statement, Dr. Plotkin explains that his deposition "covered an enormous number of subjects" which "exhausted" him.

Instead of learning from and then addressing any of the valid safety, efficacy, and ethical concerns that were addressed during the deposition, Dr. Plotkin said "more important, [he] realized that the anti-vaccination people are much better organized and financially supported than we are, and that the pro-vaccination camp must be better organized." He then laid out the steps he had taken at that point "to fight back."

These steps included:

- Making materials available for "pro-vaccination lawyers and witnesses" that would "disprov[e] the usual anti-vaccination accusations;"
- Contacting the FDA and vaccine manufacturers to add "missing information on safety and efficacy" in vaccine package inserts;
- "Lobbying the Gates Foundation to support pro-vaccine organizations and meetings on vaccine safety;" and
- Lobbying AAP, IDSA and PIDS to "support training of witnesses" in future trials so that "experts such as [himself] do[] not go unprepared unto an adversary situation.

Dr. Plotkin felt that these were the best steps to take to "help defend vaccines against attack by...clever...lawyers." Dr. Plotkin expressed that he felt threatened by groups like ICAN because "their access to the legal system is a clear and present danger, which we ignore at our peril."

In his attempt to crush out anyone questioning vaccines, Dr. Plotkin arranged a conference call with the AAP's Vaccine subcommittee to discuss next steps. He also arranged what was meant to be a secret meeting in England, the Wellcome Trust Vaccine Safety meeting, in May 2019, to discuss topics of vaccine safety. ICAN's

attorneys found out about this meeting as the result of a FOIA request and are following up to seek further information.

If all of these organizations, groups, and people would expend the same resources and energy on conducting proper trials and studies of vaccines; understanding and acknowledging the safety, efficacy, and ethical concerns raised; and developing safer vaccines, we would likely see a much more fruitful outcome. Instead, Dr. Plotkin's defensive response is indicative of the very problems highlighted within his deposition: a lack of data and transparency, which leads to a lack of trust in vaccines and in the medical professionals that refuse to address valid concerns and instead blindly and religiously push and defend vaccination.

To Dr. Plotkin's chagrin, ICAN will continue to exhaust "experts" in the vaccine and infectious disease worlds, will continue to be "clever" and organized in their questioning, and will access the legal system in order to achieve much-needed transparency and increased safety with regard to vaccine products.
